#### **DEPORTING INTRINSIC AUSTRALIANS**

This is the tragic story of a 43-year-old man who had lived in Australia for 33 years. He was educated here and gained tertiary qualifications as an Analytical Chemist from Charles Darwin University in the Northern Territory of Australia.

He was an educated Aussie who not only spoke English flawlessly but also his parent's native German.

He was a working contributor to the viability of our nation and believed throughout his life that he was an Australian permanent resident. But that belief was shattered abruptly in mid-2007.

Unfortunately, it would be mid-2015 before contacting The Australian Justice Tribunal in a desperate plea for help. At this stage he had been arrested and forcibly removed from his partner in Darwin and taken to the Yongah Hill Immigration Detention Centre in Western Australia.

The following explains our course of action which was too late to prevent the deportation of this valued Australian; a deportation that occurred while hundreds of undesirable immigrants were flooding our nation – and each of them on generous welfare benefits.
